Summary of Variation

The extension of current Engineering Expiry Date to allow trailers to stay in service till all work can be executed and certificated.

Due to the timescales involved the current EA certs will expire before the upgrade work and recertification can be conducted.

Action to Achieve Compliance

All trailers identified for upgrade are been subject to a full refurbishment including upgrade to air / oil braking and the replacement of all major hoses as required, improved LED lighting and re paint as well as the required engineering enhancements for EC certification.

The refurbishment process will run in tandem / conjunction with the recertification upgrade work and be carried out in batches of four so four trailers will be out of service at any one time to facilitate this work.

Certificate Conditions

Geographical Scope/Equipment Involved

All the trailers are utilised in the Northwest of England and are operated by Shovlin Plant Hire in support of the NWR maintenance contract for Manchester DU along with Crewe, Liverpool and Preston.

Brief Details of Requirements

332

The initial Engineering Acceptance Certificate shall be dated for a maximum life of seven years, at which time it is permissible for the vehicle to be re-accepted to the applicable documents current at the time of re-certification.

Action Taken & Why Not Practicable

All trailers to be removed from service when their existing EA certs expire and quarantined until all upgrade work is completed and machines are recertificated.

All trailers will be converted to air / oil braking and this will be carried out over the next 18 months subject to A J Hargreaves being able to supply the required conversion kits.

Arrangments have been made internally so enough engineering support is available to deal with installation as part of the upgrade / refurbishment programme.

AJH will carry out the required cross checks prior to the trailers being re-submitted for re-certification.

Severity/Degree

Trailers will have a temporary extension to current EA approval until all trailers can be reworked and upgraded to current standard and recertificated accordingly.

Control of Risk During Period of Variation/Alternative Measures

Trailers have a high reliability record which is supported by RRS data. All trailers are operated on a weekly basis and subjected to LOLER and 12 monthly inspections are per current approved maintenance plan.

Limitations of Use

- 1. Max GVW not to exceed 24 Tonnes (21 Tonnes payload evenly distributed).
- 2. Personnel are NOT permitted to ride on the trailer (unless the Rexquote Personnel Transporter PT1 is fitted).
- 3. Trailer must only be used in conjunction with a Vehicle that has compatible systems to operate trailer brakes, lights and breakaway indication.
- 4. Trailer Parking Brake On Off indicator is provided.
- 5. Trailer is **NOT** permitted to travel outside a possession.
- 6. Trailer must only be placed on or off track and loaded/unloaded in a Green Zone.
- 7. Trailer must only be placed on or off track or travelled by authorised personnel in accordance with Mandatory Rules and Regulation, equipment operating instructions and the operators declared safe system of work.
- 8. Adjacent lines must be protected when placing the trailer on or off track.
- 9. Trailer can be used under live OLE, but must NOT be used in Live conductor areas.
- 10. Trailer cannot be relied upon to operate spring loaded points.
- 11 Maximum travelling speed 10 mph. Speed over Points and Crossings 5 mph.
- 12. Maximum track cant 200mm, maximum gradient 1 in 29.
