- 3. The payload shall be evenly distributed.
- 4. The trailer shall not be used on track conditions in excess of those given in the Approved Track Conditions section of this ECC.
- 5. The trailer speed shall not exceed the values given in the Approved Maximum Speeds section of this ECC.
- 6. Exceeds plant gauge in lower sector. For gauge see Machine Data section of this ECC.
- 7. The trailer cannot be relied upon to activate train operated points.
- 8. Not to be used ALO on LU.
- 9. The trailer may be used under live OLE when used in conjunction with a Safe System of Work.
- 10. The trailer shall not be used in live conductor rail greas.
- 11. The trailer shall not be used predominantly in enclosed locations.
- 12. Hydraulic braking system may be used if the host machine is not compatible with the air brake system, though if the host machine is compatible, the air brake system must be used.
- 13. Personnel shall not be transported on the trailer, except when using the Rexquote Personnel Transporter PT1.
