3. The trailer shall not be used on track conditions in excess of those given in the Approved Track Conditions section of this ECC.
4. The trailer cannot be relied upon to activate train operated points.
5. The trailer shall only on/off-track unladen.
6. The maximum number of people to be transported on the trailer shall not exceed the value given in the Machine Data section of this ECC.
7. The maximum payload shown in the Machine Data section of this ECC shall not be exceeded.
8. The hydraulic braking system may be used if the host machine is not compatible with the air brake system, however if the host machine is compatible, the air brake system shall be used.
9. The trailer shall not exceed any speeds given in the Approved Maximum Speeds section of this ECC.
10. This trailer is suitable for on/off-tracking and travelling under live OLE when used in conjunction with a safe system of work
11. The trailer shall not travel on live conductor rail lines
12. Personnel shall not be transported on the trailer, except when using the Rexquote Personnel Transporter PT1.
